4 CHAIRMAN'S REPORT

The Chair asked if Partnership members could respond to emails as quickly as possible to avoid decision delays. The Journalist at large from Local Trust will be visiting us in September.

5 SECRETARY'S REPORT

The Secretary had nothing to report.

6 LINCOLNSHIRE COMMUNITY FOUNDATION

The equipment from the Salvation Army has been returned and is currently being stored at Mablethorpe Community Hall. The MOU between CCC and LN12 CIC is still a work in progress. Various grants forms have been sent out including one for the MABOP event in 2022. CAB are to meet with VC & KP next week prior to starting delivery of their advice service. All relevant documents have been received from Beach Bar Boxing Club, KP to send a copy to SF. KP to ask BBBC to requote for equipment as it has been 18 months since they first applied. It was agreed by the Partnership to commission BBBC from our Youth budget. Funds have now been released to Furnichurch. It was agreed by the Partnership that the Covid Recovery grants be a stand alone grant which wouldn't affect any other grants being applied for at the same time. It was agreed by the Partnership to support a grant to Sutton On Sea & Trusthorpe Carnival Committee for new bunting. It was agreed to support a £4,666.20 grant for MASA for two sets of goals, and to give them the spare defibrillator for use at Sherwood Fields. LN12 CIC, it was acknowledged and minuted at the last LN12 meeting, that LN12 CIC is a legacy project for the CCC.

7 TREASURER'S REPORT

Payments have been made to EE, Talk Talk, Facebook Ads, Phone Coop and John Kirkham. The Phone Coop contract has been cancelled.

8 COMMUNICATIONS GROUP REPORT

CW reported that Chatback has gone to press, and that all the videos recorded for the AGM are on our website.

9 PROJECT GROUPS REPORT

HERITAGE TRAIL

VC reported that we are still awaiting the Flood Risk Assessment from the EA before groundwork investigations can begin. ELDC will not help with funds to dismantle the mast where the Hera will be sited, so East Lincs Engineering have been approached for a price to dismantle the mast. Advertising consent has been submitted so we can press ahead with the information boards. We have been granted permission to use the existing redundant bathing beauties boards, which will save a few thousand pounds.

QUEBEC ROAD

The gardens have looked full of colour this summer, but we will need to re-seed some parts of it. Photos of Quebec Road have been sent into Local Trust.
