2 DECLARATION OF INTEREST

3 MINUTES

Minutes of the meeting held on 9th February 2022 were proposed, seconded and agreed as an accurate record of the meeting and signed by the Chair.

3a HERITAGE TRAIL REPORT

Paul Scott has been approached by Saul Farrell, Project Manager, Heritage Lincolnshire. HL have been awarded £2m by the Towns Fund for Heritage Street Improvements for a 5-year project. They have a grant scheme for buildings, public realm enhancements, shop front grants, repairs to vacant buildings to bring them back into use, improved planting & seating, improvements from town centre to Queens Park and a gateway feature to mark arrival into town. Saul Farrell suggested that Big Local CCC apply for a grant for £30k towards the Hera Sculpture. It was proposed, seconded and agreed by the Partnership for Paul Scott to apply for the grant on behalf of Big Local CCC with specific proviso's regarding acknowledgements of who has funded what to be included. PS left the meeting.

The cameraman from Local Trust visited last week and the Chair showed him around the Men's Shed, Quebec Road gardens and took him to meet Mablethorpe Art Group. He did various bits of filming which will be ready to view in approx. 6-8 weeks.

6 LINCOLNSHIRE COMMUNITY FOUNDATION

The Winter Warmth Scheme operated by LN12 CIC has now helped 37 people. Grants: Lincoln & Lindsey Blind Society, unable to fund as it is salaries. SOS Crafty Crafters, agreed to fund. Mabo Pride, agreed to fund, must have logo on posters etc. Carers First, one part of grant agreed, must only be people from LN12 area. SOS Bowling Club, not agreed as they have more than adequate funds in their account and have had a number of previous grants from us.

Trusthorpe Community Projects Group, agreed to fund. Bells & Whistles, not agreed as they have had a number of previous grants from us.
